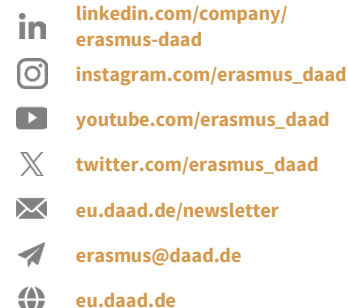

#### GOAL OF THE LONG TERM ACTIVITY

With the LTA (long term activity) on Social Inclusion in Higher Education the participating members aimed at supporting Erasmus+ National Agencies and Higher Education Institutions in their efforts to enhance social inclusion in Higher Education by

- fostering thematic exchange between stakeholders
- creating synergies in inclusion between the Erasmus+ key actions and
- collecting and analysing relevant data.

#### IMPLEMENTATION OF THE LONG TERM ACTIVITY

From March 2021 to December 2024, the Erasmus+ National Agency of Higher Education at DAAD (NA DAAD) coordinated the LTA on Social Inclusion in Higher Education through nine online sessions and one on-site meeting. The LTA consortium consisted of representatives from 13 Erasmus+ National Agencies (BE01, CZ01, DE01, EE01, FI01, FR01, GR01, IE01, IS01, NL01, NO01, RS01, SK01), the Academic Cooperation Association (ACA), and the Erasmus Student Network (ESN).

#### TRAINING AND COOPERATION ACTIVITY

At the on-site event “Moving closer to inclusive internationalisation in Higher Education” from 8-10 November 2023 in Berlin, 110 representatives from Higher Education Institutions, Erasmus+ National Agencies and expert organisations discussed various aspects of communicating and implementing inclusion measures in Higher Education.

## RESULTS OF THE LONG TERM ACTIVITY

Various topics related to inclusion and diversity were addressed in three thematic subgroups:

Subgroup 1 - inclusion reader

- Collection of relevant country specific information and data of participating Erasmus+ National Agencies
- Redesign of the inclusivemobility.eu website in cooperation with ESN: **Inclusive Mobility**
- Analysis of country specific inclusion-related data derived from the ESN student survey

Subgroup 2 - resources and data

- Collection of inclusion-related surveys designed by Erasmus+ National Agencies and post-survey reflections to create a common database that will be updated annually

Subgroup 3 - bridging Erasmus+ key actions

- Development of „Guidelines on synergies reinforcing inclusion in Erasmus+“: **Guidelines on Synergies Reinforcing Inclusion [PDF]**
- Development of “Guidelines for Erasmus+ Coordinators on inclusion” within KA2: **Guidelines for Erasmus+ Coordinators on inclusion [PDF]**
