West Pomeranian University of Technology, Szczecin
(1 January 2009 merger of **Szczecin Technical University** and **Szczecin University of Agriculture**)

- 10 Faculties
- ca. 11000 students, 920 academic staff, 970 non-academic staff
- Erasmus participant since 2000/2001
- KA103 outgoing mobility:
SMS 90, SMP 40,
STA 60, STT 20
- KA103 incoming SMS mobility: ca. 260

KA107 partner countries/HEIs choice based on:

- Priority areas defined in institutional strategy
- Former cooperation
- Historical developments

Before an IIA is signed (3 years):

- **Letter of intent** (declaration to observe ECHE, local project coordinator)
- **Questionnaire** (level of internationalisation, former experience with recognising learning outcomes)
- **Input for Quality Questions** (end of December at the latest)

Signing the IIA (January)

During the project each stage reported and monitored (information, selection, preparation, during mobility, recognition)

**KA107 mobility so far (2 years):
36 incoming (18 students), 7 outgoing (1 student)**

2015/2016:

SMS: 10 incoming, 1 outgoing

STA: 5 incoming, 3 outgoing

STT: 3 incoming

2016/2017:

SMS: 8 incoming,

STA: 5 incoming, 3 outgoing

STT: 5 incoming (2 without mobility grant)

2017/2018 (planned):

SMS: 9 incoming,

STA: 4 incoming, 4 outgoing

STT: 3 incoming

Proposed schedule:

October – November: selection of students and STA staff

Winter semester: STA mobility (added value – first-hand information on host faculty, university and country)

Summer semester: SMS mobility, STT week (selection procedure February – March)

KA107 STT week organised by ZUT:

- **Fixed training programme:**

2015/2016: ECHE requirements, management of Erasmus+ mobility projects

2016/2017: dissemination of mobility project results (Polish NA representative)

2017/2018 (May 2018): recognition of learning outcomes (Bologna expert planned)

Quick reference guide for participating HEIs in Partner Countries, p. 3

„The grant foresees organisational support (OS) of €350 per mobile participant (up to the first 100 participants; €200 for each additional participants), for both incoming and outgoing students or staff, to cover costs directly linked to the implementation of mobility activities (...). Any split between participating institutions should be **agreed upon by all partners on a mutually acceptable basis and set out in the inter-institutional agreement.**”
